

AN ORDINANCE REGULATING THE PLACING OF GRASS, SNOW, AND ICE UPON PUBLIC STREETS.

THE COUNCIL OF THE CITY OF IVANHOE, MN. DOES ORDAIN AS FOLLOWS:

Section 1. Placing snow in the streets. No person shall throw, put, push, blow or cause to be thrown, put, pushed, dumped or blow any snow or ice taken from any private premises or building or from the side of any street, lane, or alley into the roadway of any public street, lane or alley.

Subsection A. Exemption to the section 1 of this ordinance is the Business District. The Business district is as follows: From intersection of Norman & Rowena North to Railroad & Norman. Norman & Railroad west one block; Norman & Saxon East & West two blocks; Saxon & Harold one block; Saxon & Sherwood North & South one block.

Section 2. Placing grass or weed or leaves in the streets. No person shall throw, put, push, dump or blow or cause to be thrown, put, pushed, dumped or blown any grass, grass clippings, weeds or leaves from any private premises or building or from the side of the street, lane or alley into the roadway of any public street, lane or alley.

Section 3. Penalties. Any person violating any of the provisions of the ordinance is guilty of a petty misdemeanor. The first ticket issued to any person violating this ordinance is considered a warning. The second ticket issues is considered a petty misdemeanor and upon conviction shall be punished by a fine of not more than three hundred dollars (\$300.00) plus the cost of the prosecution fees in any case.

Subsection A. Exemption to the section 1 of this ordinance is the Business District. The Business district is as follows: From intersection of Norman & Rowena North to Railroad & Norman. Norman & Railroad west one block; Norman & Saxon East & West two blocks; Saxon & Harold one block; Saxon & Sherwood North & South one block. The business district section streets are bladed to the center of the street then loaded and hauled away by trucks. The Businesses in exception locations are allowed to place snow on the streets prior to the hauling away. The sections of streets defined may be increased at any time to include more streets.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication according to law.

Subsection A: Exemption to the section 1 of this ordinance is the Business District. The Business district is as follows: From intersection of Norman & Rowena North to Railroad and Norman. Norman & Railroad west one block; Norman & Saxon East & West two blocks; Saxon & Harold one block; Saxon & Sherwood North and South one block. The business district section streets are bladed to the center of the street then loaded and hauled away by trucks. The Businesses in exception locations are allowed to place snow on the streets prior to hauling it away. The sections of streets defined may be increased at any time to include more streets.

Section 4: Effective Date. This ordinance takes effect upon its passage and publication according to law.
